Miami Dade College is the largest and most diverse institution of higher learning in the United States. In his former role as an advisory board member to the University of Miami's School of Business Administration, he contributed to the creation of the Center for Real Estate Studies and Research.

Mr. Navarro is a recognized thought leader in the real estate industry. He was named president of the Latin Builders Association (LBA) in 2011, the largest Latino construction and real estate professional association in the U. S. He was also the Second Vice President and held other leadership roles for the Builders Association of South Florida.

Active in strengthening the local economic, Mr. Navarro seamlessly builds consensus with business, financial, political and community leaders to achieve strategic business objectives and financial goals. He has led trade missions to South America to drive business in Miami, collaborating with the U.S. Department of Commerce and economic development boards.
